### **A New Year and IFYE Program**

- The timing of this newsletter coincides with the beginning of a new year and a renewed invigoration of the IFYE program. As many of you are aware, the current outbound and inbound exchange numbers are drastically different from years past. While we each have had

remarkable international experiences, as with any volunteer organization, it is up to each of us to continue to promote the program. While our slides and photos might be a bit dated, the message has not changed over the decades. With the acknowledgment of the importance of international exchanges, program awareness, promotion and implementation are recognized from the highest levels of government, down to local communities and individuals.

The vision of the IFYE Association is an ambitious one. At the 2010 IFYE National Conference in Charleston, West Virginia, the membership approved the formation of a committee to develop criteria for the potential selection of an Executive Director for the IFYE Association. Much effort will go into the process including a job description, selection criteria, and obviously a way to fund this position. We believe individuals in our membership have the expertise to help guide us in this process. **Global 4-H Network Initiative** - As noted in the last issue, National 4-H Council has introduced the new Global 4-H Network Initiative. Dr. Mary Crave, 1980 WI IFYE to Sri Lanka, was selected as the Project Director for the pilot phase for work in Tanzania, Africa. This program focuses on youth development through research-based knowledge centers and technical assistance that help the Tanzania 4-H program grow. This may be an area where former IFYEs may once again impact the world with their knowledge and expertise, or be an avenue which new IFYEs will have the opportunity to impact communities, in addition to potential host families.

Larry Zilliox, a past IFYE President and YDP (Youth Development Project) delegate to Botswana in 1968, shared a few thoughts after his trip to Australia to the World Conference in 2008 and subsequent trip back to Botswana. Larry remarked, "I believe the 4-H program has some of these skill traits that should be shared around the world. We have great youth leadership and adult volunteers whose expertise could be shared."

**Out-going Board members** - I would like to extend a heartfelt thank you to out-going board members: Past President Larry Zilliox, Carol Hagen, Karen Bonnet, Judy Stewart and Eleanor Smith (completing a 'fill-in' one year term). Under Connie Fukudome's leadership and persistence, the Board was able to vastly update the Association database, clarify the Association's Bylaws and the Policy and Procedures Manual. During her two year presidency, she has contacted each of the 50 states to get updated contact information and helped inject enthusiasm and possibilities back into the organization.

**New Board members** - I would also like to welcome incoming Board members for three-year terms. They include: John Wells, MD, Region A; Ken Jones, GA, Region B; Chad Kerkman, WI, Region C; and W. Since the last issue of the IFYE News, the committee has been busy setting up activities for 2011. A December conference call welcomed the new Association President, Alan Lambert, to the committee, making us 10 strong.

A list of "core values" is being developed to aid the committee to communicate with potential international programs with whom IFYE might connect what we are seeking to achieve.

A committee workshop will be held in Washington DC from February 11 through 14. Seven of the ten on the committee plan to attend and the rest will possibly join us via Skype (Free Internet conferencing).

The purpose of the weekend is to finalize the core values from the committee's perspective and prepare for meetings with 3-4 agencies currently conducting international programs. We plan to make presentations to these agencies and, hopefully, learn where common ground and core values exist between them and ourselves. These meetings will occur on Monday, February 14<sup>th</sup>. Details will be reported to you in the IFYE News, as well as via email if we have your address.

At this time, we are just gathering information. The committee will seek alumni input and participation before any final decision is made.

If time allows in our weekend workshop, the committee will continue preliminary

work on the Executive Director project. Past Association President, Connie Fukudome, will continue to lead this sub-committee in this task. Currently, Betty Jo Roberts and Norm Bauer, from the Reconnect Committee (RC), are on the criteria development/selection team. Creating a job description is their first task. Additional members for this committee are being sought; if you are interested, please contact Connie.

Elsewhere in this issue, you will find a "Talent Search" form. The Reconnect Committee would like each person that participated in the program or is on our database (*couples will need to make copies, please*) to return the form. Everyone has talents or connections. Those that the committee feels can assist our efforts may be contacted. Please PARTICIPATE.

The State Coordinators who have maintained exchanges for those over the age of 19 since 1991 are especially encouraged to share their ideas. Two RC members, Dottie Nelson (VA) and Alan Lambert (SD), also serve as State Coordinators for the over-18 year old exchange programs in their respective states.

Finally, it is encouraged that you contact any member of the Reconnect Committee with your thoughts and opinions. (These members were listed in the last issue of the IFYE News.) You can also contact any Association Board member for the information.

### “Locally Grown, Globally Sown”

Coco Key Water Resort  
Waterbury, CT  
June 26-30, 2011

“Locally Grown, Globally Sown” is the theme for the 2011 National IFYE Conference, hosted by New England and held in Waterbury, CT. Registration opens at noon on Sunday, June 26. You have free time to enjoy the Coco Key Water Park, on site at the hotel, before the conference begins with a Mix and Mingle hosted by Connecticut’s own Mark Twain. Following dinner and opening ceremonies, Mr. Twain will share some of his international adventures.

**Monday** morning opens with our guest speaker, Gina Barrecca, a very witty and inspirational speaker. The general session will include a Plenary session on the state of the IFYE program led by Art Deisher. Your afternoon will keep you well occupied participating in your choice of workshop sessions on the Body and Mind, Green Agriculture, High Touch-High Tech or Capturing and Sharing Memories.

**Service Project** - Our service project will be introduced during our after-dinner program. The focus is on sustainable agriculture, health, and education in South Africa (<http://ecolinks.org>). 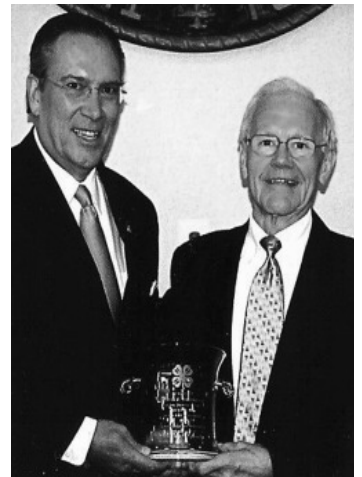

## 1965 IFYE's to INDIA REMINISCE 45 YEARS of LIFE

Forty-five years ago, in 1965, 16 young men and women representing 15 American states left for the country of India as delegates from the 4-H International Farm Youth Exchange (IFYE's official name at the time) program. Many of us are now retired and remembering the bond of being part of a unique group of persons traveling around the globe with a youthful goal of bringing peace and building cultural exchanges with an impoverished nation that touched all our hearts. As youth who were selected because of our Junior Leadership experiences and the charge to help assist in the development of India teen youth we all forged forward with confidence and determination.

And 45 years later, one of those IFYE's, Dalton Still of South Carolina decided to do something about getting us all together and with passion and determination was able to contact all of the former 1965 IFYE's to India. The monumental task of contacting all 16 of the IFYE's was accomplished

This November 14 -17, 2010, history repeated itself as 14 of the 16 were able to reunite to share their memories of that time years ago in India. We met in Branson, Missouri, a day's drive for the majority of us.

We shared remembrances of our India life together as traveling partners to the 16 existing states of that time; we further acquainted our spouses with our IFYE Brothers and Sisters and officially dubbed the "SpIFYE's". We shared how this remarkable opportunity and trip to India affected our life goals and our journey as young men and women moving forward as adult citizens.

We remember our assignment as," be an IFYE to India and represent the United States Government, the National 4-H Program and the citizens of America as goodwill ambassadors". Our uniqueness to this assignment was being sponsored by the government PL 480 wheat program in which the U.S. had an ongoing relationship with India to provide wheat as a way to help offset the severe poverty of the time. In accepting this task, not only was there to be cultural sharing by living within the Indian families but also the assignment of teaching demonstrations of what changes could be introduced to India to assure a better life for the village folks.

Partnering in this task in India were young men and women from villages who came to learn such information as cooking with a smokeless Chula (stove) to assure poisonous gasses did not contaminate their health. Also, we shared in teaching sewing projects for home use and sales, proper nutrition, and new farming methods as the steel tipped plow was a major new addition to each farmer's land management.

It seemed the people were eager to have us as visitors and to know our lives as they were just beginning to experience and develop an understanding of the role of democracy. The people of India had a great reverence for John F. Kennedy and his family and we each commonly shared Kennedy half dollars as souvenirs from the United States with our host and new friends.

Among our many common experiences upon our return to the United States, several of us revealed that we do not wear a watch these days which we felt was influenced by the difference in the concept of time that we experienced while living in India. Often we would be told we will pick you up tomorrow at 9 AM and they actually showed up two days later at 3 PM because there were other priorities or the Jeep to transport us was not available.

Much discussion and memories were shared about our government host and the tragic death of Prime Minister Lal Bahadur Shastri soon after our arrival in the country and the process to elect the new Prime Minister Indira Gandhi. Our opportunity to meet her and discuss India's future and the youth of India remains a

highlighted memory. I will always remember my thinking that two great nations at the time had women leaders - India's Indira Gandhi and Golda Meir of Israel. It was such a mystery that our own nation had not reached that status of recognizing such female leadership.

One of our assignments from the State Department was to develop a document that would share insight and recognition of the many types of struggles India had to endure as a nation from our perspective and to submit recommendations for change.

In retrospect, we each wonder if "The Document" ever made it off the shelf and into the hands of those important people who set policy and programs between India and the United States. We prefer to think that it did and we were part of a small but very significant change that began between our two countries 45 years ago.

There was a large delegation of IFYE delegates from other states attending other countries who were part of the program that year and we all had the opportunity to be at the 4-H Center for orientation and to count them among our friends. How great it would be to continue connecting to some of these other delegates.

## 4-H INTERNATIONAL EXCHANGES

With sixteen million 4-H'ers in the USA, it's curious why we don't have more interest and participation in international exchanges. Let's explore some of the reasons.

For those who do participate, are they creating excitement among the age group who would be future exchangees? We know those returning do share their experience to some degree, but we're not seeing a rush for others to join the program.

The Foundation has provided support for several years to National 4-H Congress held in Atlanta. Our support goes to the International night where those attending can sample foods from around the world in an atmosphere of being in another country. The cards and letters I receive from the participants reflect how much they enjoyed that event and express how they experienced other cultures. However, very few ever say they want to visit another country, why?

The Japanese exchange program coordinated by States 4-H brings young Japanese students, ages 11-16 to the USA. Parents begin when the children are very young, saving and preparing for such a trip. The parents pay all the fees for this trip.

We know that in the USA, we all are busy and our schedules prevent us from doing all the things we want to do. Perhaps that is also an issue. If parents don't help their children set their sights on participating, as they get older, they get involved in sports and other activities that take precedence.

What can we do? Perhaps we need to dust-off our photos and slides and give an IFYE talk. You say you went 50 years ago? Well, what has changed? Maybe we need to talk to the parents of young children to help them prepare for the future. The people in those countries we visited are still the same even though the landscape has changed. What we lived as an adopted son or daughter can be the same today. Is there a need for "world-understanding" today? I think so and I pray for world peace that comes from people understanding people.

## TREASURER'S REPORT

### 2010 and Looking Ahead

*Art Deisher*

2010 was a year of many financial gains for the IFYE Association. In the mode of the month: "Mr. President and members of the Association, the status of the Association is STRONG!"

2010 and its successes did not occur by accident. The groundwork for our gains was laid in 2009. We benefited from the:

- Strength of the reestablishment of a full Association board, representative of all the states and regions of the country.
- Completion of a current active list of volunteer state contacts from all 50 states.
- Contacting of alumni to get current contact information on our database and email addresses.

**Thresholds** we achieved in 2010 include:

- Half of the 5000 on our database have been reached for updating
- Almost 1800 names have email addresses
- Over 36 became life members this past year (*bringing the total to 1229*)
- Annual membership reached 244, exceeding our goal of 214 (*Note: annual membership for 2008, 2009, 2010 was 89, 159, 244*)
- Number of missing IFYE database persons reduced from over 900 to under 700

**Donations** - At the very end of 2010, the Association Board approved donation request letters to be sent to all life members. Due to technical difficulties, those members with email addresses were not sent. Those without email addresses were sent letters.

The letter pointed out that life members lack \$17.50 per person annually in supporting the Association equally with the \$25 annual dues members pay. Of the 305 letters sent, approximately 8% have returned generous donations equating for 220 life member shortages! Donations are still encouraged and are being received. When the email technicalities are remedied, all life members with email addresses will be extended the opportunity to participate.

**Executive Director** - In the near future, as Treasurer, I hope to be able to advance a proposed budget for the Association that includes a compensation package for an Executive Director. Others will be pursuing the details of the position, and the logistics of the working environment, but a key component is the method of funding the position.

I feel the alumni need to have input and the opportunity to review the financial structure proposed prior to the position being implemented. I encourage you to contact me directly at (800) 497-7840 on this matter, before February 10<sup>th</sup>. Feel free to leave a message and I will return your call.

## 4-H COMMEMORATIVE COIN PROPOSAL

(as of 15 January 2011)

The originator of the idea of a 2015 commemorative coin program to honor the centennial of 4-H becoming a national program says it is time to seek another organization, other than National 4-H Council, to receive 85 percent of the surcharges.

“We have tried to communicate with the leadership of National 4-H Council but they are unresponsive,” said Michael L. Ellis, the Georgia Master 4-H'er and prominent coin collector who conceived the idea.

IFYE leaders have sought a statement of National 4-H Council's intentions. On Oct. 21, 2010, CEO Donald T. Floyd Jr. said to IFYE leaders: “We are doing due diligence” and “a decision will be made in early November.” Despite repeated requests to make known National 4-H Council's decision, Floyd has not communicated since Oct. 21.

Ellis wrote to Floyd on Jan. 10, 2011, noting: “We are at the point of decision. Does National 4-H Council, as an authorized fundraising entity for the United States 4-H program, desire to be designated in the legislation as the recipient organization for 85 percent of the surcharges? If yes, we look forward to working with you. If no, we will seek other organizational partners.”

Ellis asked Floyd to respond in writing no later than Jan. 14. Ellis said on Jan. 15 that he had not received any communication from National 4-H Council or Floyd.

“We have to take the silence as a ‘No.’ We will move on to identify other organizations that may be interested and qualify,” Ellis said.

Ellis said he remains committed to the project and looks forward to working with the IFYE Foundation as the 15 percent recipient organization.

## SOLAR OVENS in Haiti

Taking part in one of the 3 trips annually put on by the United Methodist churches of the Dakotas, Ruby (Enander) Walters (ND-AU-55/56) went to Port of Prince area in Haiti along with 13 others to help in the assembly of 250 solar ovens and training seminars held for the Haitians in November 2009.

During this 2-week trip, Ruby and others worked with Haitians to assemble the ovens given out by the organization. Local individuals/families must pay a fee of \$15 USD for the oven – and that money must be already saved into one of the “micro-banks” in the area. (*Considering that if someone in the family has a job, the average pay is about \$1/day.*) Costs to the Haitians are able to be kept “low” due to many donations coming in through the mission fund for this particular outreach. Ruby indicated that in the USA, this same solar oven would cost a minimum of \$125. (*The materials for the ovens are assembled, holes drilled and packaged in Brookings, SD and then shipped to Haiti.*)

The people receiving the ovens must attend a 2-day seminar as well, after which they will receive an oven. During this seminar, they attend training sessions on how to cook with a solar oven (which will reach 350°F!), putting food together, helping to build the ovens, etc.

Each oven has three pans with covers (these are made in Haiti), oven thermometer, set of measuring cups and spoons, cook book (in English and Creole), and a water temperature gauge - so they can pasteurize water making it safe for drinking.

Ruby indicates that “Because so many trees have been cut down in Haiti, the cost of charcoal has gotten so high the people have to pay as much for the charcoal as they pay for the food - We find that many people save enough with the oven that they can send their children to school now. It is a wonderful project and now with the earthquake disasters, the ovens are even more needed. The people say that the Lord gives us the sun free! They love the solar ovens!”

The wedding - blending families as the East met the West - took place at the Anna Heights Baptist Church. The bride was given in marriage by her parents, Doug and Beth Hileman, in the presence of her extended family and friends, including the Hilemans and Bauers, and Matt’s parents and grandparents - The Song’s and Won’s from Houston, Texas, and many relatives and friends, including some from Korea.

This special event included many connected to Sarah through her 4-H and school international experiences. Attendants were her College 4-H House sisters, including Elizabeth Bruns Dixon, IL-Poland 2001. Elizabeth’s daughter, Anna, was the flower girl. Matt’s attendants were his brother, Philip, and close friends.

Wedding scripture was read by friends in their native languages - German, Japanese, Korea and English. ## **How 4-H and IFYE Impacted My Life and Outlook**

Martha Hikes Muratsuka Albin, PA-Switzerland 1966, grew up in rural Pennsylvania and never traveled further than New York or Washington, D.C., until her IFYE experience took her to Switzerland. After that, she has never stopped traveling! She does serve fondue - all the time! ... and with fondue pot, tablecloth, forks, and plates that came home with her from Switzerland - gifts from her host families.

She was an elementary school teacher in New York when she met Eugene Muratsuka from Hawaii. They married in 1970 and moved to Honolulu a week later. The only reason she’s ever left the islands is to travel - never to move!

After her divorce in 1989, it was ten years until she met and married Robert H. Albin. They met through the Kawaiaha’o Church, where they both attended. The church, founded by missionaries from New England in 1820, is known as the Westminster Abbey of Hawaii. Both are active in the work and mission of the church.



Their volunteer experience has taken them to Kalaupapa, Molokai, where only about 20 residents remain who were victims of leprosy, now known as Hansen’s Disease. Those afflicted with leprosy (or suspected of having) were shipped to the peninsula from the mid-1800s until 1969 when they were declared non-contagious and permitted to leave. Some remain since they had deformities or were no longer accepted by their families.

Her family is a melting pot of races - a combination of Hawaiian, Chinese, Portuguese, Korean, Filipino, Caucasian, Japanese, Puerto Rican and French backgrounds. Quite a combination, of which she is very proud! They have three children, four grandchildren and they sponsor two Filipino sons, Daril and Roylan through Compassion International. Martha retired in 2000 after 30 years of service with the Department of Education of Hawaii - as a

“She participated in the folk games we played at 4-H meetings & attended weekly church services with us. We took her to the state 4-H camp at Boone, Iowa, and also to the National IFYE Conference in Madison, Wisconsin, where we were fascinated with the folk dances & performances by all the IFYEs.

“I became very busy caring for seven children plus farm wife duties and could no longer continue corresponding with Batya, but am thankful that our daughter, Nancy, shares the annual Christmas message she receives from her. Nancy & her husband,

Matt’s aunts, uncles, cousins and friends from Houston, New York, and Seoul, created a small tea room in the reception hall and conducted a traditional Korean “*Paebaek*” ceremony for the wedding couple and their families. In Korean tradition, the marriage represents the joining of two families. The couple enters the room in traditional ceremonial attire, known as “*Hanbok*”. The ceremony ends with the throwing of dates and chestnuts, which the bride tries to catch in her apron. Legend says that the number caught signifies how many children they will have. The number caught by Sarah is still a secret.

teacher for 12 years and librarian for 18 years. A teacher at heart, she still volunteers in the classroom.

Martha is pictured below with two colleagues, Chloe and Karen. Chloe is of Japanese ancestry and Karen is Hawaiian/Chinese. Karen was known as *Kupuna Lei*, the Hawaiiana teacher!



Martha credits 4-H and IFYE for topping off her education. She went to a one-room elementary school with outhouses. Water was brought in from a nearby farm house. She was ready to graduate from college when she was selected for IFYE with a spring departure. She returned home to finish her degree, but not before experiencing “culture shock” in her own country. She had seen the world through the eyes of others. “I now know that my ‘spiritual gifts’ are hospitality and poverty, I would rather be giving to those in need than obtaining material goods for myself,” she comments.

“My experience as an IFYE also prepared me for living on a ‘rock’ isolated like Switzerland in many ways and to live peacefully in a neighborhood surrounded by families of many different ethnic groups with a few *haole* (foreigners, like me),” she wrote. “‘*Haole*’ is a Hawaiian word for ‘white folk,’ generally in an endearing way. I’ve spent most of my life here. Hawaii is my home!” Martha has continuing contact with her Swiss host families. Although never having had formal studies in German, she manages with everyday conversation ... and seeks help with correspondence when necessary.

Their church has many German-speaking visitors. She converses in halting German - part Schweizer Deutsch and part hoch Deutsch! They have traveled to 49 states (missed Alaska) and the Philippines, Canada, England, Germany, Scotland and, of course, Switzerland ... with the most recent - Israel just this past fall. Martha remained in contact with long-time Switzerland IFYE coordinator Herr Carl Zahn and his wife, Simone, until their deaths in 2003 and 2010, respectively. She last visited them in 2002.

## 52nd European IFYE Conference - Ursprung-Salzburg Austria 150 Attended from 18 Countries Including Twelve From U.S.

“Austrian Schutzer” awakened the whole village, not just the 150 at Ursprung-Salzburg attending the 52nd European IFYE Conference. Four Austrian men dressed in period costume shot period guns in the courtyard at 7 a.m. Those not already out of bed soon were...and the Conference got started with a “bang!”

Each day Austrian history, customs, traditions, music, foods, and more were presented. There were tours from which to choose, such as: a sheep dairy farm, tea packaging plant, Gmundner Keramik (pottery), a biological refinery, museums, a net-making company to prevent rock slides, and scenic walks. One morning was dedicated to Austrian Rescue Services. Many of the Europeans were surprised that lifesaving organizations could function with volunteers.

Those who spoke English as their native language were thrilled with the “Sound of Music” tour. It included all the buildings that appeared in the movie. The church in the wedding scene where “Maria” was married was much more ornate than it appeared in the movie. Even if Austrian schnapps had not been included, host family day was a favorite. Local farm families were hosts for an afternoon and then joined conferees at the agricultural college for a traditional Austrian dinner.

Attire for Sunday was traditional country dress. How beautiful, exquisite, and interesting each garment was. The officiate was late arriving for the church service. However, he skillfully wove getting lost into his sermon! The service was outdoors; nearby was a barn and silage pit. Ahh, the fragrance and ambiance!

An Argentinian was the host/guide at the special school for teens to 20 year olds with disabilities. He gave the tour in German and Spanish. Ellen Paine, U.S.-Costa Rica 1975 translated from Spanish to English.

The 2010 U.S. delegates were complimented throughout the week for their willing participation and their German language capability. Carolyn Gehrke was terrific at karaoke. Shane Sheridan willingly taught dancing. Kelly Moyer entertained with her wit and enthusiasm. Amy Sents was the queen of tombola sales.
